# **Meeting Objectives:**

The purpose of the seventh Planning Team Meeting was to initiate the conversation on the Far East Amenities & Public Spaces assets, challenges, needs and priorities as well as highlight and refine the draft Focus Areas.

## **Meeting Format**

The meeting began with a recap of the plan timeline and a brief introduction of the Project Team and Planning Team members. We then went over the meeting objectives and overviewed Amenities and Public Spaces related goals and vision received from previous Planning Team Meetings, Community Meetings, and community surveys. Next, our consultant, Krystin Ramirez, from MIG discussed Amenities and Public Spaces topics and elements to identify what each of these components are. Krystin also highlighted previously shown Equity Maps representing access to food, parks, and jobs to help identify gaps within the plan area and where we could enhance Amenities and Public Spaces to address specific challenges. Thereafter, Project Manager, David Powell, presented on Focus Areas and the various graphical applications that are encompassed within the Focus Areas section of the sub-area planning process. David then highlighted Focus Areas refinement based on previous Planning Team input, which, lead to discussion on each Focus Area and the vision for each one as it relates to Amenities and Public Spaces. The Planning Team provided input on seven draft Focus Areas and identified areas where

enhancements of Amenities and Public Spaces could be done. After the discussion, David concluded the meeting with upcoming meetings and how Planning Team members can provide further feedback.

## Focus Areas and Amenities & Public Spaces Discussion

## **General Amenities & Public Spaces Comment:**

• Due to the large land area that this sub-area encompasses, public art could be used as a continuous wayfinding element throughout the sub-area.

#### Focus Area 1:

- East side mobility hub at Loop 410 & E. Houston St.
- Need more greenery in the area
- Traffic calming measures are needed
- Implement more wayfinding features along this corridor
- Houston St. should be more walkable and cyclist friendly with vegetation and greenery
- Find a way to get downtown tourists, and their money, to use E. Houston corridor to access increased resources on the Salado Trail
- Wheatley Heights Sports Complex has a back gate that would lead cyclists through the neighborhood and away from the high-volume corridor of E. Houston St.
- One suggestion by the anti-violence street workers is that teens don't have enough places to gather peacefully for activities

### Focus Area 2:

- WW White has several zones that are super dark at night, with high foot traffic
- WW White Elementary has space for recreation space, and could accommodate gardening very easily
- South of Eastwood Village, there is Southwest Prep. I think they are primarily commuter coming from many areas, not just the homes to the west
- With regard to public spaces, the residential area just of the corridor, an array of violent shootings in area
- Eastwood Village neighborhood recently saw a \$7 million dollar upgrade to drainage

- Add a bike lane on Holmgreen to get people to the hike and bike trail

- Those industrial neighbors on the east side Loop 410 are pretty heavy industry. Truck noise and unpaved roads might not be a good mix near these neighbors
