Meeting: NE Loop 410 and I-35 Regional Center All Residents Open House
Date: February 21, 2019
Time: 6:00 PM – 7:30 PM
Location: 1635 NE Loop 410 (Catholic Life Building), SATX 78209
Attendees: Approximately 50

Meeting Purpose

The purpose of this meeting was for the San Antonio Planning Department to introduce the public to the planning process for the NE Loop 410 and I-35 Regional Center Plan and to gather input from the public on what they view as the NE Loop 410 and I-35 area's assets, challenges, and opportunities for the future. The input will be used to create goals for the future of the area.

Meeting Format

- Open House 30 minutes
- Presentation and Q &A 40 minutes
- Open House 20 minutes

Open House

The Open House included a gallery of poster boards that informed attendees of the study area, the purpose of a Sub-Area Plan, the project schedule, and demographic and economic information specific to the Port San Antonio Area Regional Center. Participants were invited to submit responses to a Vision and Goals Questionnaire at an iPad station and at a wall graphic station where written comments could be posted in response to four vision and goals related questions. Responses to the Vision and Goals Questionnaire will continue to be collected from the public through February 26, 2019.

Presentation

City of San Antonio Project Manager Heather Yost presented a brief overview of SA Tomorrow and the process for creating the NE Loop 410 and I-35 Area Regional Center Plan. Planning Department Assistant Director, Rudy Nino, responded to attendees' questions.

Next Steps

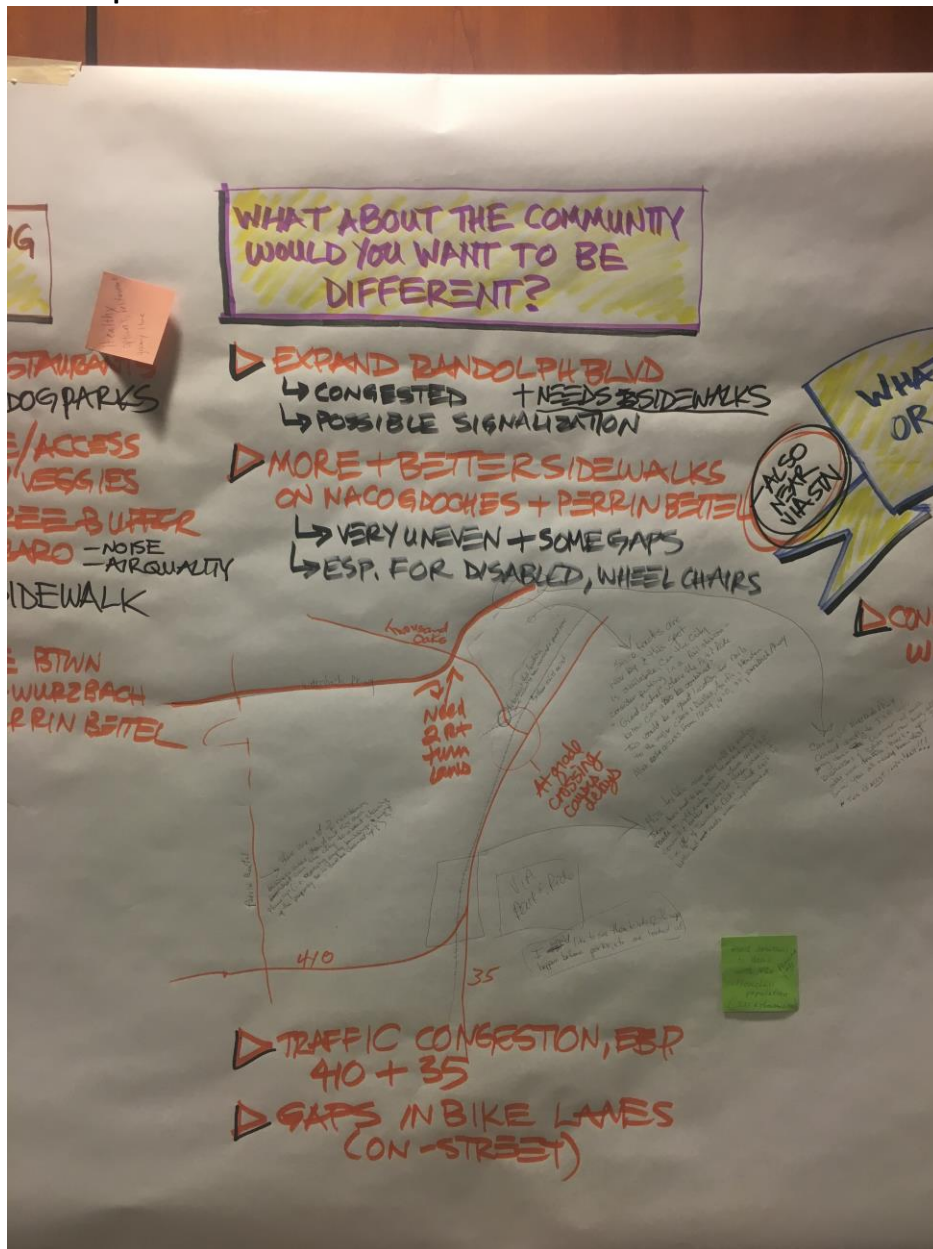

The vision and goals will be used to guide more detailed Regional Center Plan recommendations.

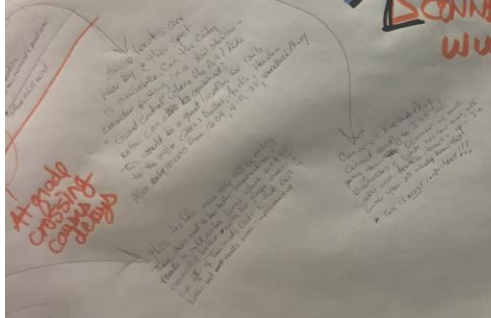
