3. Meeting Objectives

The purpose of the first Community Meeting was to gather input, from the public, to begin the development of the community's vision for the plan area. Several engagement activities, facilitated by Planning staff, were available for participants to record their feedback. The project manager had brief presentation sharing background information and introducing project process. Project manager also conversed with attendees, at various stations and throughout the meeting.

4. Meeting Format

The meeting had a brief presentation held towards the beginning of the meeting. Most of the meeting was structured as an open house so that attendees could visit each station to gather information about the project and leave input. At the entrance, a sign-in table was set up where attendees were encouraged to sign in and sign up for updates related to future public meetings, as well as general infographics related to the plan area and the SA Tomorrow planning process. The meeting space was organized into five rough stations: About the Plan/General Overview, Equity/Access Maps, Vision Board, Big Ideas, In-person Survey Station.

5. About the Plan/General Overview

Multiple boards were presented at this station to provide a general overview of SA Tomorrow and the planning process for the North Central Community Area Plan [see Figures 1 – 6]. Display boards included information about the adopted SA Tomorrow Comprehensive Plan, the Sub-Area Planning process, sample graphics from previous Sub-Area Plans, the North Central Community Area study map, and Quick Facts about the North Central Community Area.

6. Equity/Access Maps

As part of the City of San Antonio's commitment to equity, Planning Department is incorporating information about equity and access to emergency healthcare, grocery stores, public parks and amenities, and public transit into the plan [see Figures 7 – 10]. Maps to each of these were presented at the community meeting. As the planning process continues, staff and the Planning Team for the North Central Community can begin to identify underserved areas, and ultimately develop recommendations and strategies to address inequities within the plan boundary.

7. Vision Board

A visioning station was set up where meeting participants can answer three questions, by leaving a comment and, as an option, select Stock images of development types, land uses, and amenities were provided to help participants illustrate their ideas. Attendees were encouraged by staff to write their feedback on paper and attach their responses to the board. The questions asked were: "What do you like about this area?", "What is missing in the area?", and "What should change for the Future?" [see Figure 11].

8. Big Ideas

Participants were asked to write down their "big idea" for the future of the area. The responses were intended to provide broad direction for what the North Central Community Area Plan could look like in the future. [see Figure 12].

9. In-person Survey Station

A table was organized with several iPads for attendees to complete the online survey through the North Central Community Area Plan Website. The survey asked respondents to answer the following questions: *"What do you like most about this area?", "What is missing from this area?", "What would you change for the future?", "What are your 'big ideas' for the future of the area?"* In addition to answering these questions, there were optional questions that asked participants how long they've lived in the area and in their neighborhoods. [For a full list of survey responses collected, see the Survey #1 Summary.]

10. Next Steps

Staff will review feedback from the community meeting and the survey results to develop the draft vision and goals before being reviewed and discussed by the Planning Team at the next scheduled Planning Team meeting. For questions contact:




Figure 3: Sub-Area Planning Board 2




Figure 4: Sub-Area Planning Board 3




Figure 6: Quickfacts Board 2




Figure 7: Food Access Board




Figure 8: Public Park Access Board




Figure 9: Emergency Healthcare Access Board




Figure 10: Transit Access Board




Figure 11: Photo of the Vision Board from Community Meeting 1 [For a full list of responses see Appendix 1.]

Prompt: What do you like about this area?

- 12. Love Olmos Basin Park and Farmer's Market next to it. Emmanuel Church.
- 13. North Shearer Hills Grotto 2nd Block. Manhole grotto hazard to people and cars between Audrey Alene and Anne Lewis.

- 3. More Parks (Pocket Parks) for North Central. Bike / Walk bridge going from Arroyo Vista at Westmoreland to Arroyo Vista as it comes off Blanco. Plant wildflowers in ditch.

- 24. I wish the VIA project would not come to pass on San Pedro.
- 25. We need more police visibility. I live between buckeye and Neer and a lot of race driving takes planned. Zooming [?] do donuts in the streets we have people that walk which becomes dangerous for pedestrians.
- 26. Increase neighborhood walkability. Increase green spaces in public areas. Not just in parks but trees ditches and general greenery, preferably fruit, food bearing.
- 27. Why are we encouraging another 1-1 1/2 million population in this area anyways with the current drought and in spite of importing millions of gallons of already?
- 28. Eliminate the: used car dealer, tattoo shops, CBD shops on San Pedro.
- 29. Less development more green space. Better cleanup on the river going through Olmos Park.
- 30. Wonder Parkway: area should be fenced in to avoid children and pets falling in driving strong.

- 34. Edison more trees, green space, to implement an environment where growing families can inhabit, exterior lighting in the Edison neighborhood, cleaning up alleyways, fixing sidewalks, and paving streets. This neighborhood has ne neglected, the underpass on San Pedro needs to be revitalized and pedestrian walkways need lighting and safe walkways, etc.
- 35. I would change the noise ordinance to be a stricter no matter the day or time. Specifically, noise having to do with loud music and party's at residential areas. Additionally, unrelated to loud music, would be a dire need to fix the main roads like Basse which has been in disarray for a long time.
- *36. Concrete ditches for nice creeks.*
- 37. Because buckeye street has very few shops between Basse and Dresden, its acts like a good get away after shootings occur in this area. Also, alleys are good hiding spots for those hiding from the police. Perhaps they can be lit up to help police. And cleaned up by the neighborhoods. also, can identify those that drive by and dump dogs in the neighborhood.
- 38. Rehab curbs and sidewalks. Sunken/shifted curbs and sidewalks should be replaced. Broken sunken sidewalks can be a hazard and drainage problem.

APPENDIX 2: BIG IDEAS STATION RESPONSES

Prompt: My Big Ideas for the North Central Community Area are...

- 1. Provide local businesses with incentives to hire unhoused people hanging around their areas. Encourage that individual to pursue permeant employment. Win, win, for everyone.
- 2. I am up for any new changes the city does or offers. Helps city and residents. If the city can change come city residents like it and some don't like it helps environment, I am for it :)
- 1. Beautify area's 2. Fix old Buildings or remove them. 3. Fix streets and especially sidewalks.
 4. More affordable housing especially for seniors are growing generations. 5. Respect new laws + old laws of any kind. 6. Respect each other we all live in earth.
- 4. Help the unhoused. We have several unhoused standings in restaurants. Coordinate with businesses to give them small jobs, like sweeping or washing dishes for daily pay. Businesses can get incentives form the city when they participate in this idea.
- 5. Make the neighborhood a viable area for education jobs. Recreation and shopping independent of other areas in the city.
- 6. San Pedro underpass be revitalized (10 years with several binds passed and no funding allocated). 




