I. MEETING PURPOSE & AGENDA

The purpose of this meeting was to discuss the first draft of the Vision and Goals statement an introduction to land use, and to discuss potential Focus Areas for the West Northwest Community Area Plan. The agenda for the meeting included:

II. MEETING SUMMARY

The meeting began with a round of participant introductions and a recap of the Plan timeline. We then highlighted the key themes identified from feedback at Planning Team Meeting #1 and Community Meeting #1. After presenting these themes to the planning team, our project consultant Marcia Boyle gave an overview of the preliminary draft of the Vision and Goals. Following the Vision and Goals discussion, Carissa introduced Land Use, and Macro introduced the concept of Focus Areas. Zack presented some preliminary ideas for focus areas based on a vacant and underutilized parcel analysis as

well as insights already received through community input. The planning team was encouraged to discuss these and other potential focus areas within the community area plan boundary.

VISION AND GOALS

The vision and goals -convey the community's overarching ideas for the future of the area and will inform future discussions during the planning process. Below are the draft Vision and Goals for the West Northwest Area that were presented to the Planning Team.

VISION

The West Northwest Community Area maintains its strong sense of community by supporting and emphasizing the vibrancy and success of businesses, services, neighborhoods, and green space while improving and adding physical connections to and through the area.

GOALS

- Increase connectivity and accessibility to and through the area by all modes of transportation connecting pedestrians, cyclists, transit users and vehicles to key destinations, including parks, greenways, and creekways.
- Enhance existing, and create new, parks and green spaces with amenities that speak to a range of interests.
- Strengthen partnerships with local and regional groups and organizations that work in the Area.
- Improve comfort and safety throughout the West Northwest Area with additional lighting, traffic safety measures, signage, and additional resources.
- Address environmental issues including stormwater and flooding, vehicle noise, and light pollution throughout the Area to protect the areas character and charm.
- Encourage high-quality, development (residential and commercial) to be less auto oriented and more walkable, and to provide opportunities for and connections to more local businesses.

VISION AND GOALS DISCUSSION

The planning team mostly agreed with the draft Vision and Goals for the planning area. Suggested revisions from the discussion including the following topics: creating new parks in the area; emphasizing the need for alternative transportation modes; and safety, especially along trailways and creekways. Below is an image of the notes that were taken on the draft Vision and Goals board during the meeting.

FOCUS AREAS IDENTIFICATION & DISCUSSION

At the beginning of the Focus Areas discussion, Marco explained what focus areas are and what they can include, using an example from a previously adopted plan. The project manager then described potential focus areas as places where future investments, improvements, or support could be directed. These areas may also include sites suitable for preservation. In evaluating potential focus areas, staff will consider a variety of factors including vacant or underutilized parcels, commercial strips, former industrial sites, locations along transit corridors, major intersections or nodes, and special districts that may benefit from targeted investment.

The Planning Team reviewed a focus area map that included five categories of analysis: vacant sites, three tiers of Opportunity Parcels, and publicly owned land. The map also identified businesses in the area that closed between 2018 and 2023. Opportunity 1 sites are parcels with both a low floor area-to-land area ratio and a low improvement value-to-land value ratio. Opportunity 2 sites have only a low floor area-to-land area ratio (FAR \leq 0.2), while Opportunity 3 sites have a low improvement value-to-land value ratio (building coverage less than 0.5 of the parcel). The final category, Publicly Owned, includes sites that are publicly owned, underdeveloped or undeveloped, and do not currently serve a major use—making them attractive for potential development.

The purpose of the map was to highlight potential focus areas or draw attention to specific locations within the plan area. Major takeaways from the discussion include the potential to extend and connect trails, particularly near creeks and into surrounding neighborhoods, enhancing recreational and mobility options. Several areas were identified for possible redevelopment, including mixed-use projects and small, neighborhood-appropriate activity centers. Environmental concerns were raised, such as flooding issues and water quality risks near an active quarry that is reportedly being used for car dumping. Additionally, planning team members suggested combining two of the proposed focus areas into one, focusing on a better connection between Braun<u>Road</u> and Tezel Road and Braun<u>Road</u> and Old Tezel Road, promoting a more cohesive planning strategy.
